Many of you have also probably heard that Hawaii accepted the bid for hosting the 2024 World Sprint races in Hilo. You will recall that COVID derailed our past hosting effort. IVF offered the event to HCRA for 2024 and we accepted. Your Vice President and soon to be President Dana (and her amazing team) have already begun working on the event and preliminary discussions regarding sponsorship, logistics, staffing etc. are underway. The official kick-off planning meeting is going to be held **Friday, March 25 at 6:00 p.m.** via zoom.
