DUES (Non-refundable): \$100 per club AND \$10 per V1 entry.
\$10 V1 entry ONLY

FORM:

3. All information will be distributed to club contacts ONLY
 - a. As a club contact it is your responsibility to distribute information to your clubs
 - b. Pay close attention to deadlines as materials are time sensitive and may sometimes require immediate attention
4. The club contact will receive a confirmation of submission within 24 hours. This confirmation will include the total payment due.

**If your payment is not received by the deadline, your intent will be DELETED.

TRIAL REGISTRATION FORM: DEADLINE: OCTOBER 9, 2015

PAYMENT DUE BY: OCTOBER 16, 2015 (Payable to: HCRA - World Sprints)

DUES (Non-Refundable): \$30 per paddler by payment deadline.

Late Registration: \$30 per paddler registration + \$20 late fee = \$50 per paddler
(A late registration is defined as any additional names added between October 9, 2015 and November 14, 2015)

This form must be submitted by the due date in order to participate in the Hawaii Trials. Late entries may not be able to participate in Hawaii Trials or may require additional fees.
